We welcome applications from any Artisan Vendor whose products and practices are consistent with our general guidelines. Space is limited; photographs and/or samples must be submitted with application. Notice of acceptance into the Market will be determined on a rolling basis by the Market Committee. Stall spaces cost \$30 per week and are approximately 12' X 12' to accommodate a 10' X 10' tent. Vendors are responsible for providing their own tent, table and other booth set up supplies. Stall locations do not have accommodations for parking.
